PERFORMANCE/ INCIDENTS	<p>UMBRELLA MAN(1) began quickly. MARY MARY(4) was slow to begin. PEYTON MAY(3) raced wide soon after the start hampering MARY MARY(4). PEYTON MAY(3) continued to race wide in the run to the first turn, checking WINLOCK SLIM(7). BLACK INCA(2) lost ground running through the catching pen, and continued to yield ground to the turn out of the back straight, when trailing the field by a considerable distance. PEYTON MAY(3) raced wide soon after entering the home straight, hampering REAL FAITH(8). PEYTON MAY(3) and REAL FAITH(8) raced tightly nearing the winning post.</p> <p>BLACK INCA(2) was vetted and was found to be injured in the near side groin. 7 Days Incapacitation Certificate issued.</p> <p>Stewards spoke to the trainer of REAL FAITH(8) regarding the greyhounds actions approaching the finish line. Whilst the contact between REAL FAITH(8) and PEYTON MAY(3) was shoulder only, Stewards were of the belief that REAL FAITH(8) was quite conscious of PEYTON MAY(3) racing to it's inside. Whilst not taking any further action, Stewards informed Mrs Swain that the greyhounds future performances will be closely monitored.</p> <p>With regards to the actions of BLACK INCA(2) from the catching pen to the turn out of the back straight, Stewards considered the performance to be unsatisfactory, and invoked GAR 71. As a result, BLACK INCA(2) is required to trial to the satisfaction of Stewards prior to re-nomination.</p>
