MAXIMUM REFUSAL (7) switched inside the heels of SWIFT ZEAL (1) who was losing momentum. SWIFT ZEAL (1) was subject to a veterinary examination and was found to have cramped during the run. Stewards interviewed Trainer Mr Alan Clare in regard to his greyhound SWIFT ZEAL's (1) performance in the home straight. After watching the replay and taking the vet report and trainers submissions into account Stewards deemed that SWIFT ZEAL (1) had cramped in the home straight and must trial under Rule 71.
