THREE SIXTEEN (3) checked off the heels of SIMMY SIOUX (5) leaving the back straight. THREE SIXTEEN (3) checked BONITA (1) rounding the home turn, BONITA (1) losing ground, this incident hampering HAY AMOS (2).</p> <p>BONITA (1) was examined by the OTV after the event and found to have an abrasion nearside foreleg and nearside hind for which no incapacitation was applied.</p>
