INCIDENTS	<i>BACK OFF (2) and ALL OVER ROCKER (4) collided heavily on the first turn, both losing valuable ground. ALL OVER ROCKER (4) hampered BACK OFF (2) on the turn into the back straight. Then both greyhounds came together again on the home turn losing valuable ground, before finishing a distant last. BACK OFF (2) and ALL OVER ROCKER (4) were examined by the veterinary surgeon after the event and no injury was found. Both greyhounds were trialling to clear endorsements and failed. Stewards' took into account the interference suffered tonight and took no further action. Connections were advised that if the greyhounds were to trial unsatisfactory in the immediate future, stewards would possibly look at taking further action.</i>

SCRAPPED BY (2), MAC ZEPHYR (4), ROLLING STONE (5) and ZULU BEAT (8) raced tightly on the home turn, worst affected were MAC ZEPHYR (4), ROLLING STONE (5) and ZULU BEAT (8). ROLLING STONE (5) checked off the back of ZULU BEAT (8), entering the home straight.

CHEER KERRY (4) was issued with an endorsement for marring. As it was the greyhounds second offend for marring, CHEERS KERRY (4) has been suspended from racing at all tracks for a period of three months, acting under GAR rule 69 (2) (b) and must complete a satisfactory trial with two other greyhounds.</i>
