The greyhound will be prohibited from nominating until such time as a veterinary certificate is produced confirming the greyhound is fit to start.

The trainer of DUSTY HAWKE (1) was spoken to by Stewards subsequently regarding his failure to present the greyhound for a post race examination. After taking into account his explanation he was issued with a reprimand under GAR86(p) for failing to comply with the instructions of the Stewards to present the greyhound for examination by the on track Veterinary Surgeon.

The greyhound subsequently underwent a veterinary examination on 03/01/21 at the direction of Stewards. Examination revealed right shoulder muscle injury – 14 day incapacitation issued expiring 15/01/21

The injury and incapacitation information in this report was reviewed by the Veterinarian present at the meeting and confirmed prior to publication.
