BLAZIN' RINGO(1) raced wide approaching the turn into the back straight, checking MISS GABRIELLE(4), and VERY VAIN(6). From this incident, all three runners lost ground, VERY VAIN(6) worst affected, hampering MASTER SHADY(8). BLAZIN' RINGO(1) continued to race wide in the albeit with back straight, hampering MISS GABRIELLE(4). MASTER SHADY(8) momentarily looked outwardly at BLAZIN' RINGO(1) soon after entering the home straight, albeit with no contact occurring.</p> <p>Stewards spoke to Mr W Vanderburg, the kennel representative for MASTER SHADY(8), highlighting the greyhounds actions soon after entering the home straight. HUNTER LIDCOMBE(1) raced wide soon after the start, checking JILLIBY EMMIE(3), EVA'S GIRL(4), and HURRICANE HUNTER(9), with EVA'S GIRL(4) and HURRICANE HUNTER(9), losing ground. FLASHING OSCAR(6) galloped over the heels of MY BRO LARSON(5) in the run to the first turn. HUNTER LIDCOMBE(1) was checked off the heels of JILLIBY EMMIE(3) at the first turn, racing wide and losing ground from this incident, hampering EVA'S GIRL(4) and FLASHING OSCAR(6). JILLIBY EMMIE(3), MY BRO LARSON(5), and HURRICANE HUNTER(9), came together running through the catching pen. JILLIBY EMMIE(3) raced wide approaching the home turn, checking EVA'S GIRL(4), and running outwardly towards HURRICANE HUNTER(9), badly hampering that greyhound, with both runners losing ground. JILLIBY EMMIE(3) continued to race waywardly in the home straight, hampering HURRICANE HUNTER(9). JILLIBY EMMIE(3) was vetted with no incapacitation period imposed. With regards to the actions of JILLIBY EMMIE(3) approaching and in the home straight, Stewards invoked GAR 69A(1) for failing to pursue the lure. As this was the greyhounds first offence, JILLIBY EMMIE(3) was suspended at Gosford for 28 days, and is required to undertake a satisfactory trial prior to re-nomination per GAR 69A(2)(a). The winner of this event STOP THE SHINE(7) was locked away for a Urine Sample to be obtained at the Direction of Stewards.</p>
